The Medal is awarded in accordance with the following criteria:

- The Medal shall be awarded by the Committee every 2 years at the EVBO conference, commencing in 2019
- The Prize shall consist of a medal, free 1 year membership of EVBO and reimbursement of registration and travel costs to the conference.
- The Prize shall be awarded to an individual who has contributed to the work of EVBO and/or holds EVBO membership and, in the judgment of the members of the Committee, has made a sustained, outstanding contribution to the development of vascular science and whose research had a significant international impact.
- An outstanding contribution would be an important scientific discovery or introducing new technology that opened new avenues in this field of research.
- A list of candidates should be drawn up by the Medals Committee from names put forward by the EVBO Committee members in the year preceding the conference.
- Every Committee member can nominate a maximum of two candidates, providing a brief justification (maximum 1/2 page) with the candidate's short CV (maximum 2 pages including key publications) attached. Self-nominations will not be considered.

- Selection procedure:
 - The Medals Committee shall submit to the EVBO Committee a list of candidates with a brief justification and their short CV (maximum 2 pages including key publications)
 - All Committee members will take an electronic vote.
 - The Medals Committee will prepare a brief report containing the recommendation of the chosen candidate for the Medal.

- The Medal shall be presented every two years and the recipient is invited to give a special lecture at the EVBO meeting.

The EVBO Lecture is awarded in accordance with the following criteria:

- The Lecture shall be awarded by the Committee every 2 years at the EVBO conference, commencing in 2019
- The awardee will present their lecture and receive reimbursement of registration and travel costs to the conference.
- The Prize shall be awarded to a young scientist within 12 years of PhD and as an individual who, in the judgment of the members of the Committee, has published work of a high standard and has the potential to become an international leader in vascular science.
- A list of candidates should be drawn up by the Medals Committee from names put forward by the EVBO Committee members in the year preceding the conference.
- Every Committee member can nominate a maximum of one candidate, providing a brief justification (maximum ½ page) and the candidate's brief CV (maximum 2 pages including a list of publications from the last 5 years).

- Selection procedure:

- The Medals Committee shall submit to the EVBO Committee a list of candidates with a brief justification (maximum ½ page) and their brief CV (maximum 2 pages including key publications from the last 5 years).
- All Committee members will take an electronic vote.
- The Medals Committee will prepare a brief report containing the recommendation of the chosen candidate for the Lecture.

- The Lecture shall be given every two years at the EVBO meeting.
